## **Chair Mary Ann Fontana began with introductions of speakers**

1. Ellen Lipton State Board of Education spoke about public education in Michigan

Brief overview of what the state board of education does:

- We are a local control state, which means a lot of what we do occurs at the local level.
- Task is to hire and fire superintendent and so forth.
- State Board of Education is governed under Public Act 287 of 1964, which followed the constitutional language. It tracks very clearly the statutory framework of what the State Board of Education can and can't do. In sections 9 and 10 it tracks very similarly the language of the constitution. It's advisory in nature. It has the authority to enact broad policy, but certainly does not have the ability to enact legislation.
- Unless the legislature passes a law, no one has the capacity to enforce that. What they must do under the law as it's passed by the legislature is carry out the law. The State Board of Education has the capacity to hire and fire the superintendent, who is Michael Rice. He is charged with the officer or executive officer of the department, so if the State Board of Education wants to direct the officers to do something, they have to direct Michael Rice to do so. The State Board of Education speaks through its policies, statements, and resolutions. Encouraging the state to wave the testing for this year. Every parent has a right to opt their child out of the state test. The federal government will not punish states for not meeting the requirement of the 95% rate of testing.

## What is going on with the return to school?

Early research has shown that stay-at-home schooling has been disproportionately distributed among low-income households, having a toll on the emotional and mental health of our students. For many of those students, learning remotely has been a crisis.

We also know that students have been kept remote for fear of the coronavirus. Every district was required to submit a return-to-learn plan. They must revisit that plan every month. They must submit every month to the Department of Education the reports, then go to the State Board of Education for evaluation. These reports list the number of school districts that are fully remote, the number of school districts that are fully in person, the number of districts that are hybrid, meaning partially remote, partially in person. Rather than follow federal guidelines, the state legislature has put their own conditions in place to appropriate the federal funds in their efforts to take control away

from the governor. We cannot return to school now because we are a national hot spot, due to rising cases of coronavirus in our state. Governor Whitmer has asked schools to pause learning. Only the legislature can mandate. The department of Health and Human Services has declined to tell schools to shut down. Local school districts have been left to scramble in terms of deciding whether they stay the course or forego the money, or what they do. The State Board of Education issued a resolution back in December before Ellen Lipton got on the board, reminding schools to adhere to their return-to-school plan.

Ferndale school district will be building a new elementary school on the Casa/Jackson Park site. Jackson Park has a deed restriction, so to build an elementary school there, they need 50% + 1 of the homeowners to sign off on the deed restriction. COVID update:

Michigan has received 7.4 million doses.

Oakland County has received 852,000 doses.

Oakland government has received 241,000 doses.

What that means is 40% of people 16 and up in Oakland County have received at least one COVID vaccine dose. At least 60% of people 65 and up should have received at least one dose. Michigan has the biggest surge right now so be very aware and very careful.
