

Meeting Minutes—November 16, 2023 @ TCEC, Ferndale

- I. **Welcome**: Our Chair, **Glenda Stainback**, called the meeting to order at 7:00 PM and welcomed everyone.
- II. Approval of Agenda—by acclamation
- III. Approval of September Meeting Minutes—by acclamation
- IV. Report on November 7 Elections
- A. **Gwen Turner, Royal Oak Township City Clerk**: Ferndale, ROT, and Hazel Park constitute a group. Gwen enjoyed meeting people from all three communities. Early voting—9 days prior to Election Day—proved not be as successful as we had hoped. People didn't seem to know about it, and the turnout was small. However, early voting gives people another option, besides absentee voting, and voting on Election Day. There is hope for the future of early voting.
- B. Victoria Mitchell, Berkley City Clerk (Heidi Barckholtz, Huntington Woods City Clerk, was not able to join us, so Victoria agreed to attend): Victoria enjoyed having contact with other clerks during the election process. There are over 13,000 registered Berkley voters. There are over 5000 on the permanent absentee voter list but 2723 on the permanent absentee ballot list. There were only 12 early voters during the nine days prior to Election Day. There were 3350 total voters (26%), of whom 2146 were absentee voters. Major challenges include staffing to manage all the work involved in a multi-option process, outreach education to inform people about options and process, and funding to support the entire process. The positives include giving voters options and more voter engagement. Needed are more workers, a more complete database, and more security. In addition to election responsibilities, the City Clerk is the keeper of records, administers the office, is in charge of special licenses (e.g., dog license), etc.
- C. Ed Norris, Oak Park City Clerk: Ed has been involved with 32 elections, starting with the start of his career as a clerk in 2008 and his work as the City Clerk for OP in 2012. The population of OP is about 30,000, with 26,000 registered voters. There was a 20% voter turnout for the November election. Major challenges include staffing and volunteers to manage the volume of work involved in a multi-option process, outreach education to inform people about

options and process, and funding to support the entire process. Absentee ballots need to be turned in early to make it easier for staff on Election Day. In the future, they can be tabulated/counted during the days of early voting. Same day registration on Election Day is not helpful. People should register to vote earlier, again to help staff, especially those working the Election Day.

The Q/A included, among others, an emphasis on getting young people involved early to engage them and recruit them to help as volunteers. City clerks and lay people going into the high schools of our communities will happen in April/May. Partnerships are being formed.
