

### Meeting Minutes, June 15, 2023

- Welcome New Members: Glenda Stainback called the meeting to order at 7:00 PM. She welcomed everyone and any new members. Daniel Dena of Huntington Woods was attending his first OPHWROT Dem Club meeting.
- **II. Approval of Agenda:** Don Jones made the motion to approve the agenda, and Laurie Lisi seconded it. The agenda was approved.
- **III. Approval of May Meeting Minutes:** Laurie Lisi made the motion to approve the May Minutes, and Kris McLonis seconded it. The Minutes were approved.

### IV. Guest Speakers

- State Sen. Jeremy Moss and State Rep. Jason Hoskins: Elliott-Larsen Civil Rights Act Expansion: Rep. Hoskins could not be with us this evening, and Senator Moss spoke on his behalf as well. Senator Moss misses his former district, but he loves his current district. His and others' priorities have been worker's rights, tax relief, reproductive freedom, and the expansion of the Elliott-Larsen Civil Rights Act to include equal protection under the law of all rights. It is important to be loud and clear re: LGTBQ+ rights and protection of the highly vulnerable trans community. Promises were made, and promises have been kept by the State Legislature because of the Democratic majority, which we all have to work to keep. Senator Moss ended his remarks by saying that the Detroit Chamber of Commerce has been supportive all the way with this bill. And the Grand Hotel on Mackinac Island began flying a Pride Flag on June 1 for Pride Month.
- 2. **State Rep. Helena Scott**: **Making Juneteenth a State Holiday**: House Bill 4457 has been passed by the House and will go to the Senate soon. Juneteenth will be celebrated in MI just like other state and federal holidays. She provided a

historical perspective on Juneteenth; history matters. It is important to speak truth about the past and the present. We have come a long way, but we still have lots to do to inform people about the history of slavery and its repercussions to this day. There is also legislation coming re: DTE issues, and input is needed from the constituencies. Rep. Scott re-introduced **Greg Humphries**, who often speaks on her behalf at our and other meetings.

- 3. Carla Wallace: Juneteenth Celebrations in Oak Park: This celebration of Juneteenth, the third for OP, will take place on June 18 on the Community Center grounds. It will include a one-mile walk at 9:45 AM (registration at 9:00 AM), and local art displays, arts and crafts, a band, and, from 4:00 to 6:00 PM, a program that will honor local students, fathers, and elected officials and performers.
- 4. Daniel Dena: Juneteenth in Huntington Woods: This celebration of Juneteenth will take place on June 19 from 6:00-8:00 PM outside of the Rec Center. It will include music, a program with a keynote speaker (Professor Ollie Johnson, Chair of the African American Studies Department at WSU), information and books for children especially focused on Juneteenth, and much more.
- **5. Genean Joshua: The ROT Juneteenth Celebration** will take place on June 17 with a speaker and program (details TBA). A fireworks celebration will occur on July 1 (details TBA).
